Newfoundland and Labrador's tech sector already contributes more than \$1.8 billion annually to the provincial economy and has grown by 24% in less than a decade. In 2025 alone, Newfoundland and Labrador tech companies accounted for nearly 80% of all investment deals across Atlantic Canada, raising \$295.5 million, according to Entrevestor.
